

## **ORTHOPAEDIC TECHNOLOGIST I, JOB GROUP 'K' ( 2 POSTS)**

### Salary Scale

**Ksh.31,020 x 1,560 – 32,580 x 1,620 – 34,200 x 1,710 – 35,910 x 1,800 – 37,710 x 1,890 – 39,600 x 1,990 – 41,590 p.m.**

#### **(a) Duties and Responsibilities**

Work at this level largely involves the management of orthopaedic supportive services in a health unit at a national, provincial or district hospital. Specific duties include planning, supervising and co-ordinating supportive services in orthopaedics in a unit as well as allocation of duties and distribution of staff to various sections. In addition, the officer will be expected to ensure availability of supplies and equipment. Alternatively, work may include training, counselling and guiding students; participating in curriculum development, implementation and evaluation as well as recruitment of candidates for training.

#### **(b) Requirements for Appointment**

For appointment to this grade an officer must have:

- (i) Have completed at least three years' service in the grade of Orthopaedic Technologist II.
- (ii) Have shown considerable initiative, competence and efficiency in planning, organizing and discharging duties and responsibilities at the level of Orthopaedic Technologist II;

#### **OR**

Have passed a Diploma course in Medical Education in the case of officers deployed in a medical training institution.

## **DEPUTY CHIEF ORTHOPAEDIC TECHNOLOGIST: JOB GROUP 'M' - ( 1 POST)**

### Salary Scale

**Ksh. 41,590 x 2,070 – 43,660 x 2,220 – 45,880 x 2,310 – 48,190 x 2,400 – 50,590 2,550 – 53,140 x 2,700 – 55, 840 p.m.**

#### **(a) Duties and Responsibilities**

Duties and responsibilities at this level involve overall management of supportive services in orthopaedics in a national hospital. Specific duties involve participation in planning, supervision and co-ordination of orthopaedic supportive services. In addition, the officer will be expected to ensure availability of supplies and equipment; participate in the supervision and counselling of staff working in the hospital. Alternatively, the officer may be deployed in a medical training institution where he will be responsible for planning, curriculum development, implementation and evaluation of training programmes. Or, the officer may be the Head of the Department of Orthopaedic Technology in a medical training institution.

#### **(b) Requirements for Appointments**

For appointment to this grade an officer must have:

- (i) Have completed at least three years' service in the grade of Senior Orthopaedic Technologist; and
- (ii) Have considerable experience and in addition have demonstrated ability, technical competence and efficiency in organizing work and discharging responsibilities at the level of Senior Orthopaedic Technologist.
