The County Government of Nyeri invites capable bidders to express interest for Participatory Forest Management Plan for Tumutumu Hill.

TERMS OF REFERENCE FOR TUMUTUMU PARTICIPATORY FOREST MANAGEMENT PLAN

Overall objective. - A reduction in poverty through ensuring that the forest contributes to improving the lives of the poor while restoring the environment.

Purpose- improved forest and woodland management and utilization practices. Terms of reference include and not limited to the following.;

1. Undertake social-economic and livelihoods analysis taking into account the interaction between the forest reserve and zones of influence.
2. Analyze the land use around Tumutumu considering different actors.
3. Map investment opportunities in the area
4. Undertake infrastructure analysis
5. Propose the appropriate biodiversity and eco-system management options.
6. Make full use of zonation where applicable to reflect the differing site conditions and relationships with stakeholders.
7. Undertake a SWOT analysis of the stated management objectives to identify deliverable strategies and tactics. Collaborative approaches should be emphasized.
8. Develop criteria and indicators for monitoring and evaluating the management plan. This should include a clear differentiation of wood production (if applicable), social and environmental objectives and a ranking of each which will accord the management priorities agreed.

QUALIFICATION

The consultant should have the following qualifications and experience. (Attach copies of Certificates)

- Masters degree in relevant field of forestry.
- A minimum of 5 years working experience.
- Relevant experience in social-economics and working with forest adjacent communities.

- A business or economics qualification would confer additional advantage.
- A thorough understanding of natural forest management in Kenya.
- Experience in forest planning and development of management plans particularly.
- Proven ability to synthesize and write clear reports in English.

Bidders must also attach copies of:

1. PIN Certificate
2. Valid Tax Compliance Certificate

The Interested bidders should submit their bids in 2 copies clearly marked Original and Copy appropriately.

Shortlisted candidates will be selected on the basis of the expression of interest submitted and invited to prepare a detailed Request for Proposal.
