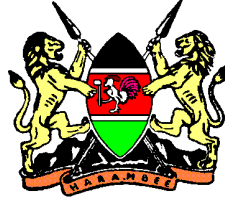

### EXPRESSION OF INTEREST FOR MANAGEMENT/ LEASE OUT OF KARATINA MARKET ABLUTION BLOCKS

The County Government of Nyeri, through the department of Water, environment and Natural resources seeks to lease out the ablution blocks at Karatina market and their management.

Karatina market has 9 ablution blocks. 8 of the blocks, two per floor, consist of both women and men section with each having 5 and 4 sitting WC toilets respectively, 2 sinks each and 2 urinal bowls in the men section. The other ablution block has the men section having a drainage urinal area, one squat WC toilet and a sink area, while the women section has 4 latrines, 1 squat WC toilet and a sink area. The market is expected to house approximately 1500 traders excluding hawkers, customers and passersby and thus the ablution blocks are expected to serve a large population.

The scope of management of each ablution block will include

1. Round the clock cleaning of the ablutions and their facilities using proper detergents (more frequently during market days)
2. Maintenance of the ablution blocks, and the associated costs (including water costs, asset repairs and management)
3. Provision of sanitary bins and their disposal in the women toilets
4. Operation of the toilets, with a sufficient staff number and toilet papers, including charging of use

Interested groups with capabilities to manage the facilities are invited to submit an **expression of interest** giving a brief of their capabilities to manage an ablution block in Karatina market as per the scope of work.

The bidders should provide the following:

1. Certificate of incorporation /registration.
2. Valid tax compliance certificate
3. Valid AGPO certificate
4. PIN Certificate
5. Registration document from NCPWD for PLWD
6. Any other relevant information
7. Serialization of tender document is mandatory

Complete tender documents **MUST** be submitted through the IFMIS SUPPLIER PORTAL: [www.supplier.treasury.go.ke](http://www.supplier.treasury.go.ke) (NEGOTIATION NUMBER:703227) so as to be received on or before the date and time indicated in the IFMIS PORTAL.
