Introduction

All other present leaders gave their opening remarks emphasizing on the importance the public participation exercise.

BRIEF OF ESP MARKET

The Chief officer Trade, gave a brief of economic stimulus package market (ESP), noting that His Excellence the president had directed that the designs for ESP markets be revised so that they can accommodate at least 200 traders. The design should include a cold room, ICT Hub, a Creche and a food court to attract not only the market businesses but take care of the youth and young mothers.

Chief officer also noted that at the end of public participation the traders were required to answer the following questions.

1. Whether they had accepted the market to be built where it was?
2. They would be required to give an undertaking through unanimous consensus by a show of hands that they would occupy the market once built.
3. They will help the County Government in the day to day management of the market including anti-vandalism, utility management and discipline.

REMARKS FIELD MARSHAL MUTHONI KIRIMA MARKET

Nyeri Municipal Board Chairman's Remarks

The chairman Mr. Jeremiah Ichaura pointed out that the establishment of economic stimulus markets is an essential strategy for fostering growth, supporting local businesses, and encouraging consumer spending. These markets serve as a vital lifeline, especially for small and medium-sized enterprises, providing them with the platform to reach new customers, boost sales, and create jobs. The chair encouraged participants to freely give their views on the proposed ESP Market project.

Municipal Manager Remarks

The municipal manager gave a brief on the progress of Field Marshal Muthoni Kirima market noting that a lot had been done, but there was still room for more improvement. She urged the traders to participate diligently to make sure that their needs are met by the proposed designs.

Assistant County Commissioner Remarks

Assistant County Commissioner Mr. Samuel Nyaga noted that the National government was building 181 similar ESP markets across the country. The government was supporting market development as a way to improve livelihoods of its citizens. He insisted that the traders needed to give an undertaking that they will occupy the market once built.

MCA Rware Ward Remarks

He started by appreciating the noble gesture by His Excellence the President, to include Field Marshal Muthoni Kirima market as one of the ESP markets to be constructed by the Government.

He requested the traders to give their views calmly as every opinion matter.

Traders remarks

The clothes section traders started by appreciating the County and National Government for selecting their market as one of the 181 ESP markets to be constructed across the country. They requested that the market be an open-air market which can fit all traders. They also requested assurance that the current and future designs will accommodate all 1500 traders.

Food section traders requested that the design to conform to a wholesale and retail market including a farmer's market. They also want the market to be built from perimeter wall to perimeter wall.

DECLARATION OF FIELD MARSHAL MUTHONI KIRIMA MARKET TRADERS

1. Traders unanimously agreed to have Field Marshal Muthoni Kirima Market constructed where it was situated.
2. Traders unanimously gave an undertaking that they will occupy the market once built.
3. Traders unanimously agreed that they will help in the management of the market once complete to prevent vandalism, indiscipline and misuse of utilities.
